## I. <u>ELECTION NEW BOARD MEMBER.</u>

Justin Reppe advised the Board that Jennifer Hanson would like to be the Board representative from Dorsey & Whitney. A motion was made and seconded to approve Jennifer's appointment to the Board. The motion passed unanimously. Justin welcomed Jennifer to the Board. In accordance with the Bylaws, Jennifer's term will expire at the Annual Meeting in 2025.

## II. MINUTES.

#### III. TREASURER'S REPORT.

## IV. REPORT OF LEGISLATIVE COMMITTEE.

She further advised those provisions relating to MMB have been shared with Jen Hassemer at MMB. Joe Bagnoli went on to discuss the bill on "who is a lobbyist." There was a hearing on the bill. However, MIPF did not participate. MIPF has a meeting set up for March 20 to discuss this bill and the impact it may have on the members of our organization. Joe discussed with the Board various other items of interest at the legislature.

#### V. EDUCATION COMMITTEE.

Dan Miller reported on behalf of the Education Committee. Dan reported he and Nicole Pehrson will meet in the near future to discuss ideas for 2025. Kimberly K. Ganley reported the Twins game outing has been scheduled for April 23 and that invitations would be sent out shortly to those members who have paid their 2025 dues. If a member has not paid their dues, their invitation will be withheld until such time as they have paid.

## VI. <u>NEW BUSINESS</u>.

- A. <u>Membership Subcommittee</u>. Heather Casperson, as a member of the ad hoc membership committee, discussed with the Board reaching out to possible new members. There was further discussion that Dan Andersen would like to assume the Vice President-Legislative position, with Rhonda Skoby being an active member of the Legislative Committee and reporting at the Board meetings on behalf of the committee. After some discussion, a motion was made and seconded to approve Dan Anderson assuming the Vice-President-Legislative position, with Rhonda Skoby reporting on behalf of the Legislative Committee.
